

TOWN OF OTISCO
LOCAL LAW #1 OF 2007
INTERIM TOWN HIGHWAY SUPERINTENDENT SALARY INCREASE

Be it enacted by the Town Board of the Town of Otisco, State of New York, as follows:

§1 Purpose

The Town of Otisco Town Board has determined that the Annual Salary for the position of the Interim Town Highway Superintendent be increased to the amount of Forty-Three Thousand Five Hundred Dollars (\$43,500.00) for the year 2007, to maintain the quality of the services provided.

§2 Authority

This Local Law is enacted pursuant to the provisions of Town Law § 27(1), § 81, §§ 90 - 94. The Local Law adopted is subject to a permissive referendum. All references in this Local Law to New York State Law shall apply to those sections of such laws which are in effect at the time of the effective date of this Local Law and to any subsequent or similar provisions of New York State Law.

§3 Effective Date

This Local Law shall take effect upon its filing in the Office of the Secretary of State in New York State in accordance with the provisions of New York State Municipal Home Rule Law §27.

§4 Definitions

As used in this Local Law, unless otherwise expressly stated or unless the context or subject matter requires otherwise, the following terms shall have the following meanings:


- (1) *Interim Town Highway Superintendent* – A person who holds the office of Town Highway Superintendent during a period prior to the next election for the Office.
- (2) *Annual Salary* - Salary for a certain one calendar year period.

§5 Severability

If any section, paragraph, subdivision, or provision of this Local Law shall be adjudged by a Court of competent jurisdiction in the State of New York to be void, invalid or unenforceable, such adjudication shall apply only to the section, paragraph, subdivision, or provision so adjudged, and the remainder of this Local Law shall remain valid and in full force and effect.

§6 Prior Law

Upon the effective date of this Local Law, this Local Law shall supercede the provisions of any prior Town Local Law, Ordinance or Regulation which are inconsistent with the terms of this Law.


