HIGHWAY

The paving is done for this year. Superintendent Eipp inquired if it possible to use anyone other than Suitcoat for the Paving Company. The board said we can research, as long as they are on county contract there should be no problem.

The new plow should be here in April, the old plow will go out for auction.

The Salt Shed needs to be stained or painted. Is this something the Town can do or does it need to go out for bid? The walls are pressure treated wood.

Residents on JC Avenue inquired about the creek that crosses Otisco Valley Road that needs be cleaned out. Superintendent Eipp was told that the town has nothing to do with that creek and the residents should contact the County or DEC.
