PUBLIC HEARING re: Cell Tower

Application for Odium Sites as the agent for Vertical Bridge, LLC to construct a 200+ ft communication tower @ 4885 Canty Hill Rd

JR Lynch as representative of Odium Sites, agent for owner of tower. Mr Lynch provided a detailed and thorough application for the cell tower per Craig Billinson including the SEQR short form part 1. Attorney Billinson concludes "there is no anticipated adverse environmental impact relative to construction of the tower and the project falls under an unlisted category under SEQR." Craig has completed the town parts (2 and 3) of the SEQR short form.

JR Lynch took the floor to describe the progress of the tower. As soon as the building permit is issued, Vertical Bridge will begin marketing to all the carriers. When there is one cell carrier interested in the tower, the construction will begin. Once begun it should take approx. 3 months to build.

Supervisor Hall asked to the anticipated interest in the cell tower by carriers. Mr Lynch responded that there is a federal mandate to cover all areas and and this tower aligns with that.

Additional notes:

Power requirements were discussed and assumed to be adequate.

The building permit will be revised to cover additional carriers.

There will be an 8 ft fence with barbed wire and the elevation is around 1400 ft.

Construction analysis will be covered by the codes inspector.

JR Lynch and Odium will hand off the project to Vertical Bridge at this point.

Motion to close the Public Hearing was made by Councilman Spaulding and seconded by Councilman Volles.

TOWER BUSINESS

Attorney Billinson presented documents to be signed regarding the SEQR report Odium and Vertical Bridge provided and completed by Attorney Billinson on the Town's behalf. He reiterated the project is an unlisted action and has no adverse environmental impact. Supervisor Hall signed the License. The Codes Enforcement Officer, Robert Hayes can now issue the building permit. It is noted that a separate driveway permit will be necessary.

Attorney Billinson proposed a Public Meeting Resolution be posted in the Syracuse Newspapers stating the Public Meeting has been held, a representative appeared and questions welcomed.

Motion was made by Councilman Roger Volles and seconded by Councilman Jesse Spaulding to Accept SEQR review as being complete and accurate indicating a negative declaration that the tower will have no adverse environmental impact.

It is noted that Vertical Bridge has provided a bond for \$70,000 for the tower removal. It is also noted that the town waived the permit application fee based on the benefit to the town and a new permit will not be necessary for additional antenna,. The current permit would be modified accordingly.

We are working on the walking trail. There was a little wash-out.

We are planning on paving Kamm Road, between Kinyon and Oak Hill.

CHIPS paperwork came in. Updates will need to be made per Thomas Chartrand.

Some surface treatment will begin late June or July.

New sign at highway shop.

Still working on trees at lower walking trail.

New signs on walking trail.

New Stake Rack Truck came in, waiting for a body for it. Has a recall.
