RESOLUTION #5 2024

Motion was made that the elected and appointed official's salaries be paid as follows:

RESOLUTION #6 2024

Motion was made setting the reimbursement for mileage while on town business be \$.67 per mile.

RESOLUTION #7 2024

Motion was made that reimbursement for meals while on town business shall be made in accordance with the federal IRS standard per diem rates.

RESOLUTION #9 2024

Motion was made authorizing the Supervisor to sign the contract with Thomas Chartrand Accounting in the amount of \$17,000.00 for the year 2024.

RESOLUTION #10 2024

Motion was made designating Terrence F. Fischer Town Justice. as the voting delegate to attend the 2024 Annual Meeting of the Association of Towns to be held in New York City on February 18, 2024. The alternate being Georgette T. Waldau Town Clerk. Necessary expenses incurred shall be reimbursed when proper vouchers are submitted.

RESOLUTION #11 2024

Motion was made agreeing to the signing of Agreement to Spend Town Highway Funds.

RESOLUTION #12 2024

Motion was made that the standard workday for elected and appointed officials is to be six (6) hours for the purpose of determining days worked reportable to the New York State Local Employees Retirement System.

RESOLUTION #13 2024

Motion was made authorizing the payment of utilities by Supervisor Glenn R. Hall as they come in as not to incur a late charge on billing. It shall also be noted that the supervisor is authorized to approve vouchers for postage stamps.

Motion was made setting the pay scale for jurors in the town of Otisco at \$22.00 per day.

RESOLUTION #18 2024

Motion was made to leave the fines set in the Anti-Dumping Ordinance for the Year 2024 the same as for the year 2023.

RESOLUTION #19 2024

Motion was made regarding health insurance provided to Highway Superintendent, Douglas Hoffman, a full-time employee. The town of Otisco pays 80% of premium for health and dental insurance coverage and the employee pays 20% of premium for health and dental insurance coverage and the employee is also responsible for paying their own vision in full through the OCEBA plan X. For retired employees and for the Highway superintendent the town of Otisco pays 100% of health insurance for single coverage through the OCEBA plan X.

Motion was made by Councilman Jesse Spaulding and seconded by Councilman Roger Volles to approve the preceding 19 RESOLUTIONS, excluding Resolution #14 at this time.

Supervisor Glenn Hall gave a brief discussion on the proposed Local Law #1 2024 on Wind Turbines. This Local Law covers the small, less than 20-megawatt Wind Turbines in the town. The maximum height is 80 ft. for residential and 150 ft. maximum for agricultural farms.

Motion was made by Councilman Peter Murphy and seconded by Roger Volles to close the Public Hearing on Local Law #1 Wind Turbines and open the second Public Hearing on Local Law #2 2024 a Moratorium on Commercial and Industrial Construction.

PUBLIC HEARING ON MORATORIUM ON COMMERCIAL & INDUSTRIAL CONSTRUCTION

Supervisor Glenn Hall discussed the reason for the moratorium on Commercial and Industrial Construction, explaining that this is for anyone wanting to create a business and build on their property. The Town Board deems it necessary to impose a moratorium to allow the Town Board to review its local laws and any applicable State and Federal Laws which may impact the Town. This moratorium is for 1 year.

Motion was made by Councilman Jesse Spaulding and seconded by Councilman Roger Volles to close the Public Hearings on Wind Turbines and on Commercial and Industrial Construction.
