# FROM THE SUPERVISOR

Supervisor Hall provided details on the contractual terms with the Onondaga county Sheriffs dept regarding the enhanced detail that the town will be utilizing in 2024.

Supervisor Hall has been in contact with representatives from Palmer Capital on the proposed Wind Turbine project and asked them to attend the March 2024 board meeting to answer questions from the town residents.

# RESOLUTION #24 2024

Motion was made Councilman Roger Volles and seconded by Councilman Jesse Spaulding to oppose the granting of IDA benefits and PILOT agreements for any project that is residential in significant part. The Town Board does not believe residential developments create long term jobs or economic benefits to municipalities, such as the Town of Otisco. The Town Board also opposed granting PILOT agreements to property owners or developers of renewable energy projects since the federal government and the State of New York already provide incentive and subsidies for these types of projects. The Town Board also opposed the OCIGA granting PILOT agreements to property owners of developer who seek to develop land within the Town of Otisco for purpose of conducting activities that would have a high potential for degradation of the Towns rural and agricultural character or the Town's natural resources.

The Town Board also requests the time for extension of benefits and PILOT agreements to qualified commercial and industrial projects not exceed 10 years in length.

The Town Board should be given adequate time to consider the financial impacts of the prosed PILOTS and other issues specifically related to the Town of Otisco and to communicate any concerns to IDA before the IDA adopts any proposed revisions to OCIDA's Uniform tax Exemption Policy
