Thomas Chartrand, Financial Advisor gave an overview of the monthly spending and revenue for February 2025.

BUSINESS DISCUSSION

<u>Wind Turbines</u> – Per Supervisor Hall the town was asked to review our current wind and solar local laws. Currently our wind and solar laws point to anything over 20 megawatts would fall under the jurisdiction of ORES. Also noted that the current presidential administration may change federal policy and funding of wind and solar projects. Considering this development the board has decided to update the current laws that may benefit the town if federal rules change. The town will be adding battery storage system requirements to the existing wind and solar laws. The timeline for the proposed changes will probably be 2-3 months. The changes made by the Town of Lafayette will be considered as a guideline.

Dave Garlock asked about "protected airspace." Supervisor Hall said that was a topic to be discussed at a May meeting with the Town of Lafayette and Town of Tully supervisors.

Attorney Billinson also discussed the changes made by Lafayette to their zoning laws. He is intending to incorporate many if not all those requirements in future laws and amendments.

Resident Ann Ruggles spoke to the work of Southern Hills Wind Watch Group and the request that the Town create additional laws addressing other concerns.

Attorney Billinson also noted that our fire departments are probably not equipped to manage lithium battery fires.

Ann Ruggles brought up the topic of "ice throws" from the turbines and the danger that could pose especially if the winters are as intense as this past winter.

Dave Garlock asked if the Association of Towns had made any progress on renewable energy regulations. Supervisor Hall is not aware of anything.

Dave Garlock asked if we have received any results from the test towers. Supervisor Hall has not spoken with Palmer Capital since late January.

<u>Wonderland Forest</u> – Court date rescheduled to March 13. It was noted that there are several pending lawsuits against and within WL Forest.

Adult Use Law – Onondaga County has approved our Adult Use Local Law.

Motion was made by Councilman Knapp and seconded by Councilman Spaulding to schedule a schedule a public hearing at the April Town Board Meeting at 7:00 pm.

New DEC Wetlands Information – Attorney Billinson attended a webinar on new regulations implemented in December 2024. A million additional acres of wetlands were identified, and the DEC is actively implementing new requirements for permitting development on or near identified wetlands. The DEC has released preliminary maps and recommends that the code enforcement officer become familiar with the wetlands within his jurisdiction.

Front Entrance-Councilman LaFrance will check in with the contractor on scheduling.

<u>Permanent Outdoor Generator</u>- The Board/Town may need to address the need for some formal regulation.

<u>IT</u> - Supervisor Hall will speak with Benjamin Bibik regarding transferring control of the domain name to TripleCitiesTech per Kurtis Florance's (CEO TCT) request.

Motion was made by Councilman Volles and seconded by Councilman Knapp directing the Town Clerk to post the Standard Workday Report.
